

ORDINANCE NO. 14-2

AN ORDINANCE PROVIDING FOR PAYMENT OF PREVAILING WAGES FOR PUBLIC WORKS PERFORMED FOR THE ROCHESTER FIRE PROTECTION DISTRICT, SANGAMON AND CHRISTIAN COUNTIES, ILLINOIS IN ACCORD WITH 820 ILCS 130/0.01 ET SEQ.

WHEREAS, the State of Illinois has enacted an act entitled "The Prevailing Wage Act" which requires the determination and payment of prevailing wages to persons who are employed on public works projects which enactment is contained at 820 ILCS 130/0.01 et seq.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE ROCHESTER FIRE PROTECTION DISTRICT:

SECTION I. To the extent and as required by said enactment, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of the Rochester Fire Protection District is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Sangamon and Christian Counties, Illinois area as determined by the Department of Labor of the State of Illinois as of June 1, 2014.

SECTION II. Nothing herein shall be construed to apply the determined prevailing wage rate to any work or employment except public works construction of the Rochester Fire Protection District, and only to the extent that payment of such wages is required by said enactment and not otherwise.

SECTION III. The determination of prevailing wage rates for construction work in the Sangamon and Christian Counties, Illinois area as determined by the Department of Labor of the State of Illinois as of June 1, 2014 shall be incorporated herein by reference and as set forth in the schedule of wages which is

attached hereto and made a part hereof, being the schedule of prevailing wages for construction trades for Sangamon and Christian Counties, Illinois as determined by the Illinois Department of Labor, Conciliation and Mediation Service. As required by 820 ILCS 130/0.01 et seq., any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede that Department's June determination and apply to any and all public works construction undertaken by the Rochester Fire Protection District. The definition of terms appearing in this Ordinance shall be the same as in the aforesaid Act.

SECTION IV. This determination of prevailing wage rates shall be made publicly available for inspection by any interested party in the Firehouse located in Riverton, Illinois.

SECTION V. A copy of this determination shall be mailed to any employer or any association of employees who have filed, or file their names and addresses with the District requesting copies of such determination.

SECTION VI. A certified copy of this Ordinance No. 14-2 shall be filed with the Illinois Secretary of State and the Department of Labor of the State of Illinois as required by law.

SECTION VII. The Secretary of the Board of Trustees of the Rochester Fire Protection District shall cause a Notice to be published in a newspaper of general circulation with the area encompassed by the Rochester Fire Protection District stating that the Fire Protection District has made a determination of wages for public works, which such publication shall constitute notice of the determination's effectiveness and that said determination has been made and is available for public inspection as indicated herein.


