VIII. New Business

Presentation was made by one of Rochester Fire/Rescue Firefighters who is a Paramedic RN presenting a *Video Laryngoscope* used in intubation. Intubation is a procedure using a tube to open of maintain an airway on a patient who cannot maintain it on their own due to an accident or sudden illness. This is an advanced instrument used by our Intermediate and Advanced (Paramedic) EMT and RN's that are currently on the department. Currently they are using a manual Laryngoscope of which they had previously receive training on. This is an effective instrument in clinical environment but can be difficult to use in a first response or field environment. The proposed "*Video Laryngoscope*" allows the procedure to be performed much quicker and effectively in the first response setting where minutes are crucial.

Motion was made by Trustee Leonard for the purchase of the instrument and second by Trustee Fox. There was no request for further discussion and the motion was passed by unanimous vote.
